¹Gift Aid – What is it?: Barnardo's can claim Gift Aid from the Inland Revenue on many donations. This is worth an extra 28p for every £1 donated at no extra cost to the donor. To qualify for this the donor must TICK the Gift Aid column above to indicate they want the donation treated as Gift Aid and they pay UK income or capital gains tax equal to the tax we can reclaim on the donations. They must also include on the form their: NAME, full HOME address (including postcode) and the DATE the donation was made to enable us to claim back the Gift Aid. Please read the declaration below before ticking the Gift Aid box next to your donation:

¹Gift Aid - Declaration: I am a UK tax payer and not related to the named participant (please see the note below ^A). Please treat all donations I make on or after the date shown as Gift Aid donations

^A PLEASE NOTE - If the participant is entered through their own place, and they do not intend to apply for a full or partial refund of any of their costs from Barnardo's, then the 'related' clause does not apply. If this is not the case, any donations made by the participant themselves, or a spouse of the participant, or a close relative (namely siblings, ancestor (e.g. mother, father, grandparent), or lineal descendant (e.g. son, daughter, grandchild), or a spouse of a close relative would fail the donor benefit rules and so are not eligible for tax relief under the Gift Aid Scheme.
