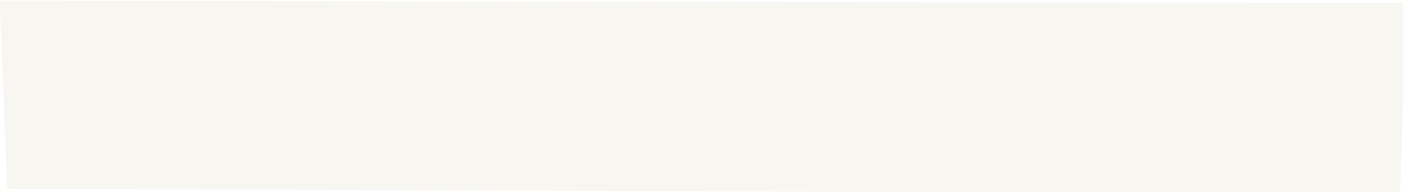
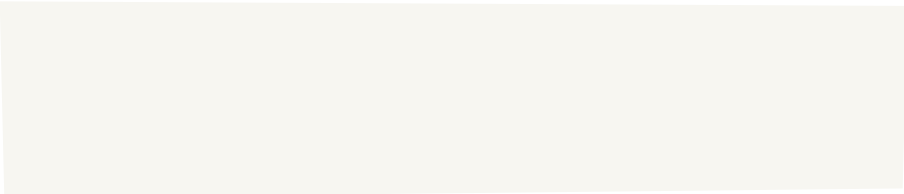


# FUNDRAISING SWEEPSTAKE



# RUNNING YOUR SWEEPSTAKE

1. Choose Your Topic: Pick a theme for the game. It could be anything you like, such as a sports tournament, baby names, or your favourite snacks.
2. On the sheet, write your question, prize and the suggested donation amount (we recommend £3).
3. In the terms & conditions section of the sheet enter your name, contact address, the closing date of the sweepstake and the date the winner will be revealed.
4. You must ensure that only people aged 18 above participate in your sweepstake.
5. You must not sell entries to the sweepstake on the street or house to house.
6. Ensure data collected from sweepstake participants is kept safe, is securely destroyed after the sweepstake ends, that you only collect information that is required to notify the winner. You must ensure you comply with data protection legislation. Visit the Information Commissioner's Office [ico.org.uk](http://ico.org.uk) for more guidance.
7. Ask each participant to write down their selection and name on the sheet. Each answer must be different from one already chosen.
8. The person who chooses the correct answer to the question you have asked or, if a question such as 'How many sweets in a jar' has been used, the person whose guess is the closest to the correct answer will win the prize.
