



## Barnardo's NI Golf Day 2026

### Terms and Conditions for Four-Ball Team Registration

These terms and conditions apply to Barnardo's NI Golf Day event (the "Event") taking place on Friday 12<sup>th</sup> June 2026. The Event is promoted by Barnardo's, registered charity in England & Wales (216250) and Scotland (SC037605).

All funds raised will be used to support services in Northern Ireland. While it won't be restricted to a particular, project, it will go to areas of Barnardo's work where it is needed the most across the region. If we are fortunate enough to exceed the funds needed for our services in Northern Ireland, every additional pound raised will be directed towards supporting children, young people and their families across the UK.

By registering for the Event you confirm that you and all individuals included in your Four-Ball team understand and agree to these Terms and Conditions. It is the responsibility of the lead booker to ensure that all team members or guests are made aware of and comply with these terms.

#### 1. Event Registration

- 1.1. Registration is open to individuals aged 18 and over only.
- 1.2. Each four-ball team must consist of 4 participants.
- 1.3. Evening tickets for Four-Ball team members are included in the price of the of Four-Ball team registration. Evening tickets are also sold separately from Four-Ball Team registration and are available to all attendees, including non-golfers, guests, and supporters who wish to join the post-tournament dinner and entertainment.

#### 2. Cancellations, Changes and Refunds

- 2.1. If the Event, or any part of the Event, is cancelled due to circumstances beyond Barnardo's control (e.g. severe weather, public emergencies, or national mourning), no refunds will be issued including for registration fees, travel, or accommodation costs.

- 2.2. Barnardo's may change the event date, start time, or format at its discretion. We will notify participants as early as possible. No refunds will be issued in the event of such changes.
- 2.3. If you or any member of your registered team are unable to attend, the registration fee will be treated as a donation to Barnardo's. You may request to transfer your place(s) to another participant, subject to prior approval from Barnardo's.

### **3. Dress Code**

- 3.1. All participants must adhere to the Golfing Union of Ireland or Ladies' Gold Union standard dress code. The following items are not permitted:
  - a) Denims
  - b) Shorts (unless tailored)
  - c) Football or rugby tops
- 3.2. Only tailored shorts are permitted. Please ensure your attire is appropriate for a golf club setting.
- 3.3. Golf spikes may be worn on the course.

### **4. Health, safety and fitness**

- 4.1. The Event may involve physical exertion and carries a risk of injury. It is the responsibility of each participant to ensure they are medically fit to take part. Participants are advised to consult a medical professional before the Event if they have any concerns about their health or fitness. Individuals must not participate if they feel unwell or are otherwise not in a suitable condition to safely take part.
- 4.2. Participants must follow all instructions provided by Barnardo's event marshals and golf club officials.
- 4.3. Barnardo's accepts no liability to the extent permissible by law for personal injury, loss, or damage to personal property.

### **5. Liability**

- 5.1. Nothing in these terms limits any liability which cannot legally be limited, including the liability of a party for death or personal injury caused by that party's negligence.
- 5.2. Subject to clause 5.1, participants take part in the Event at their own risk and will not hold Barnardo's, the golf club or anyone working with or for Barnardo's responsible for any accident, injury, or illness, for any damage to property, or for any losses that might occur as a result of participation in the Event.

## **6. Data Protection**

- 6.1. Barnardo's will comply with the UK General Data Protection Regulation (UK GDPR) and the Data Protection Act 2018 to ensure your personal data is handled lawfully, fairly, and transparently. This includes using your data to administer your attendance and participation in the Event, to communicate with you about the Event, and for other purposes where we have a lawful basis, such as your consent or our legitimate interests.
- 6.2. Barnardo's will use the personal information provided at point of registration for the Event, for the purpose of administering your registration and attendance in the Event.
- 6.3. Barnardo's will work with trusted third-party partners to help administer the Event. This includes Edenmore Golf and Country Club, Edenmore House, 70 Drumnabreeze Road, Magheralin, Co Down, BT67 0R, NI040604
- 6.4. Barnardo's does not share your personal data with third parties for marketing purposes.
- 6.5. Barnardo's may occasionally contact you to share updates about the work your contributions help fund and other ways you can support us. Barnardo's will only contact you by Email, SMS, or telephone if you have given us explicit consent to do so. Barnardo's may also contact you by post under our legitimate interests, unless you have opted out.
